

GENERAL TERMS AND CONDITIONS OF THE ELI TOKEN MIGRATION

November 2019

READ THESE TERMS AND CONDITIONS CAREFULLY BEFORE MAKING ANY DECISION IN RELATION TO THE MIGRATION OF ELI TOKENS. BY REQUESTING ANY ACTION IN RELATION TO THE MIGRATION OF ELI TOKENS, YOU ACKNOWLEDGE THAT YOU HAVE READ THESE TERMS AND CONDITIONS AND THAT YOU AGREE TO BE BOUND BY THEM. “YOU” MAY REFER EITHER TO YOU OR TO THE ENTITY YOU REPRESENT.

1. ELI TOKEN MIGRATION

To enable its users cheaper and faster transactions, Eligma Ltd., a company registered in Slovenia under company registration number 8106452000 and located at the address Letaliska cesta 33F, 1000 Ljubljana (“**Eligma**”), will migrate the ELI token from the Ethereum blockchain to the Bitcoin Cash blockchain. ELI token migration means that you will need to send your ELI tokens to a deposit address that you will receive on this website in order to receive the same amount of new GoCrypto tokens to the SLP address that you will provide.

When migrating to the new network, the ELI token will change its name and become the GoCrypto token “**GoC**”). The GoC operates on the Bitcoin Cash-compliant SLP protocol (Simple Ledger Protocol). You can find more information about the SLP protocol at <https://simpleledger.cash/>.

If you own ELI tokens and you want to send your ELI tokens to our deposit address, it is considered that you accept the contents of these General Terms and Conditions of the ELI Token Migration (“General Terms”).

These General Terms apply exclusively to the ELI token migration process and do not regulate any other legal relations between you and us.

These General Terms do not apply to the ELI tokens in the Elly mobile wallet since those have already been automatically migrated to the Bitcoin Cash blockchain.

For 1 (one) ELI token, you will receive 1 (one) GoC.

2. ELI TOKEN MIGRATION PROCESS

To be able to successfully transfer ELI tokens to the new network, you must follow these steps:

2.1. Installation of the Badger Wallet mobile application

The Badger Wallet is an official Bitcoin Cash wallet with SLP support (it accepts tokens), capable of accepting new GoC. You can install it on your mobile device (Android, iOS) or as a plug-in in your browser (Chrome, Firefox). After installing it, we strongly advise you to create a backup by writing down the seed phrase.

You create a backup by pressing the “Back up your wallet with a Seed Phrase” button. The seed phrase consists of 12 words; it is recommended that you write them down on a piece of paper. In that case, you will be able to reconstruct your Badger Wallet if your phone gets stolen or damaged.

2.2. Obtaining your SLP address from your Badger Wallet

Following the installation of the Badger Wallet, you will have to obtain your SLP address from your Badger Wallet, since your Badger Wallet generates a SLP address to receive new GoC. In your Badger Wallet, press the “Receive” button on the bottom menu. Copy that address to the clipboard on your mobile device by clicking the SLP address.

2.3. Entering the SLP address into the form and the obtainment of the Ethereum deposit address

You have to enter the SLP address that you copied to the clipboard on your mobile device into the online form on this website and confirm it. Then, the form will display the Ethereum deposit address where you need to send your ELI tokens. Please save and copy the address as you will need to send your ELI tokens to it.

2.4. Sending your ELI tokens to the Ethereum deposit address

You then send your ELI tokens to the Ethereum deposit address you received before. This process differs depending on which of the following wallets your tokens are stored:

i. Private Ethereum wallet

If you keep your ELI tokens in your private Ethereum wallet, follow the instructions on using myetherwallet with Keystore file at https://kb.myetherwallet.com/en/offline/offline_transaction/.

Please also note that, for transferring the ELI tokens, you need a small amount of Ether on your wallet for the transaction gas. A regular token transaction currently consumes 0.000042 ETH (the market price is approx. \$0.008).

ii. Metamask

If you keep your ELI tokens in the Metamask wallet, follow the instructions on using Metamask at <https://metamask.zendesk.com/hc/en-us/articles/360015488931-How-to-send-tokens-from-your-MetaMask-Wallet>.

Please also note that, for transferring the ELI tokens, you need a small amount of Ether on your wallet for the transaction gas. A regular token transaction currently consumes 0.000042 ETH (the market price is approx. \$0.008).

iii. Hardware wallet (Ledger, Trezor)

If you keep your ELI tokens in a Hardware wallet (Ledger, Trezor), follow the instructions at <https://kb.myetherwallet.com/en/transactions/how-to-send-a-transaction/>

Please also note that, for transferring the ELI tokens, you need a small amount of Ether on your wallet for the transaction gas. A regular token transaction currently consumes 0.000042 ETH (the market price is approx. \$0.008).

iv. Online exchange (i.e. Livecoin)

If you keep your ELI tokens on an online exchange (Livecoin or tokens.net), you need to transfer them to the Ethereum deposit address obtained from this website in accordance with the following instructions:

Step 1: On the online exchange, find your ELI tokens in the “Balance tab”. Click the Withdrawal button.

Step 2: Enter the amount of the ELI tokens you want to transfer in the “Amount, ELI” field. Paste the Ethereum deposit address in the “ELI token address” field. Click the “Send a Payment” button.

2.5. Receiving GoC

After you send your ELI tokens to the Ethereum deposit address, you will (instantly) receive the same amount of GoC to the SLP address of your Badger Wallet. You will be able to check the transactions on our goc.eligma.com website by clicking the “Check transactions” button. Alternatively, you can check the transactions on this page: simpleledger.info.

3. ELI TOKEN MIGRATION PERIOD

The ELI token migration period will last from November 25, 2019 23:00 CET to May 31, 2020 23:00 CET. We will keep reminding you of the migration via social media to make sure that you transfer your tokens in time.

AFTER THE END OF THE MIGRATION PERIOD, ALL NON-MIGRATED ELI TOKENS WILL BE PERMANENTLY LOCKED (UNTRADEABLE/ LOST/ WORTHLESS), SO PLEASE ALLOW YOURSELF ENOUGH TIME FOR THE MIGRATION PROCESS.
